Highlights

This section provides major observations related to Statistics of the Inland Coasting Trade Consignments of India during the period April 2022 to March 2023

Gujarat (GJ) and Goa (GA) were top two contributors with shares of 37.71% and 18.61% of total value in Outward Movement of InlandCoasting Trade Consignments in 2022-23 respectively.

West Bengal (WB) was top contributor with share of 70.26 % of total value of INWARD movement, Kerala (KL) comes after West Bengal with the share of 13.03 % of total value of INWARD movement.

West Bengal (WB) had maximum share of around 59.25% of total value related to INTERNAL movement, Gujarat (GJ) was in the second place with around 28.62% of value of INTERNAL movement.

During the period April 2022 to March 2023, Gujarat had maximum share of around 100% of total value (Rs. 88.37 Cr) of OUTWARD movement related to the commodity of HS 09 i.e. COFFEE, TEA, MATE & SPICES. Whereas, Kerala had share of around 90.08% of total value (Rs. 79.6 Cr) of INWARD movement of the same commodity.

For HS 27 commodity i.e. Mineral Fuels, Mineral Oils And Products Of Their Distillation, Bituminous Substances, Mineral Waxes; Gujarat had maximum share of around 42.24% of total value (Rs. 39141.42 Cr) of OUTWARD movement and for INWARD movement, West Bengal had the maximum share of around 86.01% of total value (Rs. 79694.22Cr). West Bengal had lion share of around 94.07% (Rs. 2303.93 Cr) of INTERNAL movement of the commodity of HS 27.

For the commodity HS 72 i.e. Iron and Steel, Andhra Pradesh had maximum share of around 48.7% of total value (Rs. 8695.95 Cr) of OUTWARD movement and for INWARD movement and INTERNAL movement, Kerala had the maximum share of around 48.45% of total value (Rs. 8649.63 Cr) and Tamil Nadu had the maximum share of 98.89% (Rs. 34.11 Cr) respectively

For HS 84 commodity i.e. Nuclear Reactors, Boilers, Machinery And Mechanical Appliances; Gujarat had maximum share of around 73.96% of total value (Rs. 28.92 Cr) of OUTWARD movement and for INWARD movement and INTERNAL movement, Kerala had the maximum share of around 78.8% of total value (Rs. 30.82 Cr) and Tamil Nadu had the maximum share of 100% (Rs. 0.17 Cr) respectively

It is observed that during the period April 2022 to March 2023, for HS 08 digit product i.e; HS 27101949 (HIGH FLASH HIGH SPEED DIESEL FUEL CONFORMING TO STANDARD IS 16861) comes out to be the leading HS 08 digit Commodity for INTER-STATE movement and HS 08 digit product i.e.; HS 29024300 ((P-XYLENE) comes out to be the leading HS 08 digit Commodity for INTERNAL movement

Chapter One

Introduction

This chapter provides a brief background of the Inland Coastal Trade Consignments of India during the period April 2022 to March 2023

- 1.1 *Coastal Trade Statistics* are the data on Trade Consignments of commodities passing from one port to another by sea within India. It does not include external trade i.e. international trade done by India with other foreign countries. The statistics for which are available at the DGCI&S portal (www.dgciskol.nic.in).
- 1.2 The present publication is based on the Daily Trade Returns (DTRs) received from different ports and Customs Authorities on regular basis. Custom authorities capture the information from relevant entry of Bills giving details of the inward consignments moving through different ports.
- 1.3 This year the Lakshadweep is not covered in this publication as no special data received for the period April 2022 to March 2023 from the Assistant Commissioner of Customs, Cochin, which used to be received before.
- 1.4 For the purpose of Coastal Trade Statistics, Sea ports of India have been grouped under 11 States/UTs viz. (1) Andaman and Nicobar Islands, (2) Andhra Pradesh, (3) Goa, (4) Gujarat, (5) Karnataka, (6) Kerala, (7) Maharashtra, (8) Odisha, (9) Puducherry (10) Tamil Nadu and (11) West Bengal. Information received from these ports along with Custom Authorities are being compiled by Ancillary division of DGCI&S and a report on “Statistics of the Inland Coasting Trade Consignments of India” is published annually and uploaded on the website of this office for the use of various users as well as subscribers.
- 1.5 It is worthwhile to mention that data (DTR) received from different ports are not very regular and this office could not validate all the data received from all ports.

Chapter Two

Concepts and Definitions

This chapter discusses about various concepts and definitions used in collection of relevant data and their presentation in various forms of tables and charts for this publication

- 2.1 Business transactions between any two State/UTs covered under inter-State or internal-State consignments.
- 2.2 Accordingly, data on shipments between one port to another within the same state are treated as the Internal trade of the concerned state and are taken into account separately in compilation of Coastal Trade Statistics. On the other hand, the movement of consignments from one state to another is treated as Inter-State trade. Further, the Inter State movement of goods have also been classified on the basis of their State of origin and State of destination.
- 2.3 Movement of goods classified on the basis of origin is shown as Outward movement of goods from the States and the movement of goods classified on the basis of their destination is shown in the tables as Inward movement of goods into those States. The commodities are presented as per the ITC (HS) 08-digit classifications as adopted for Foreign Trade Compilation.
- 2.4 From last two years a new initiative has been started. This office receives some data from the port offices which do not contain commodities traded. Value of goods of such transactions have been statistically estimated using rest of the data received from other sources rather than discarding such precious information. This helped in increasing the coverage of this publication significantly.
- 2.5 It is, however, admitted that in absence of data from all ports this report is not fully exhaustive.

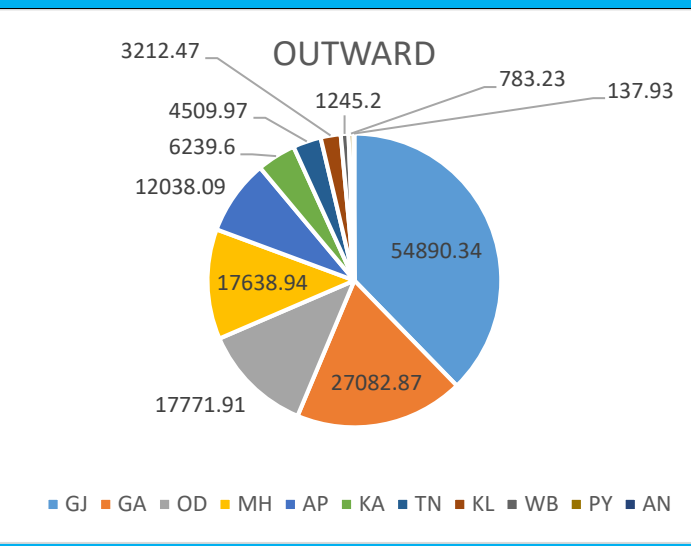


FIGURE 3.2V :: Pie chart showing share of INWARD Movement of Inland Coasting Trade of VALUE in Rs. Crore of ALL Commodities

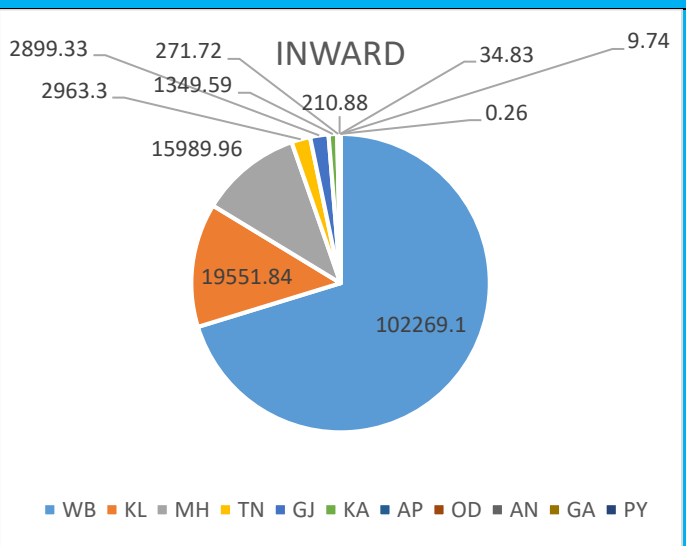
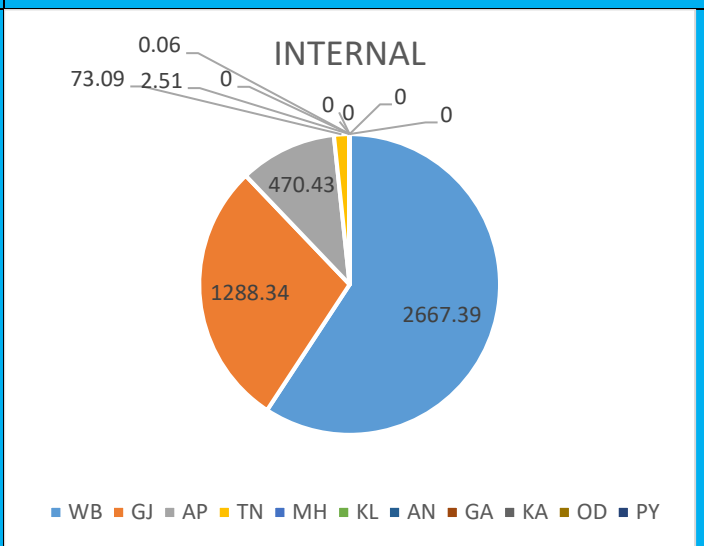


FIGURE 3.3V :: Pie chart showing share of INTERNAL Movement of Inland Coasting Trade of VALUE in Rs. Crore of ALL Commodities



From the above STATEMENT 3.1V and FIGURE 3.1V it is observed that during the period April 2022 to March 2023, GJ comes out to be the maximum contributor having around 37.71% share of total value of OUTWARD movement, GA comes out to be the SECOND STATE having around 18.61% share and OD comes out to be the THIRD place with 12.21% share of OUTWARD movement. Thus the above three STATES hold around 68.53 % of value of OUTWARD movement of considering all Commodities.

From the above STATEMENT 3.2V and FIGURE 3.2V it is observed that during the same period, WB comes out to be the top contributor with 70.26 % of total value of INWARD movement, KL comes out to be the SECOND most state having around 13.43 %share of total value of INWARD movement, and MH comes out to be the THIRD STATE with 10.99 % of share. Thus the above three STATES hold around 94.68 % share of total value of INWARD movement considering all Commodities.

From the above STATEMENT 3.3V and FIGURE 3.3V it is observed that during the period April 2022 to March 2023, WB comes out to be the FIRST amongother states with 59.25% share of total value of INTERNAL movement, GJ comes out to be the SECOND most contributor with 28.62% share and AP comes out to be the THIRD with the share of 10.45% of total value of INTERNAL movement. Thus the above three STATES contributed around 98.32% share of total value of INTERNAL movement considering all Commodities..

FIGURE 3.2A: Percentage Share of States/UTs* in total value related to Outward movement of Goods from 2021-22 to 2022- 23

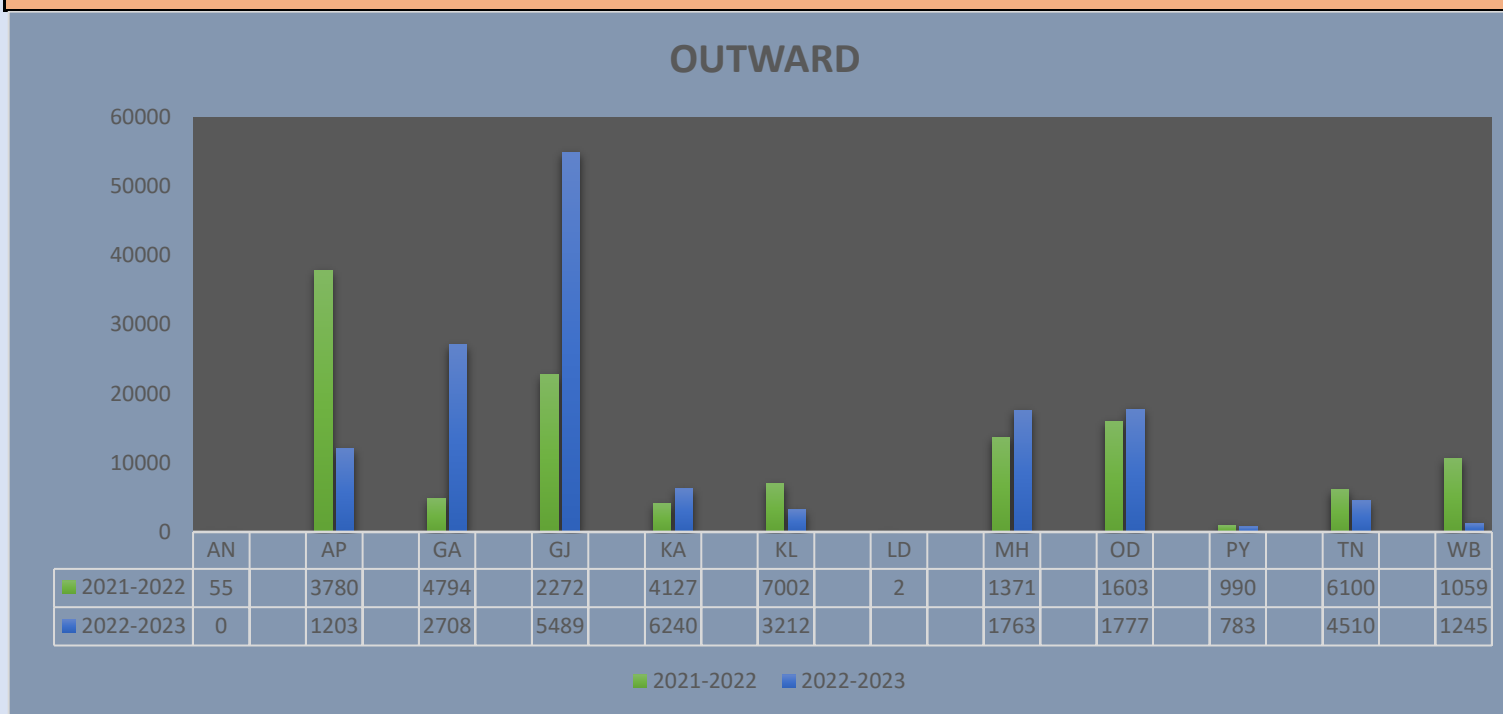


FIGURE 3.2A: Percentage Share of States/UTs* in total value related to Inward movement of Goods from 2021-22 to 2022- 23

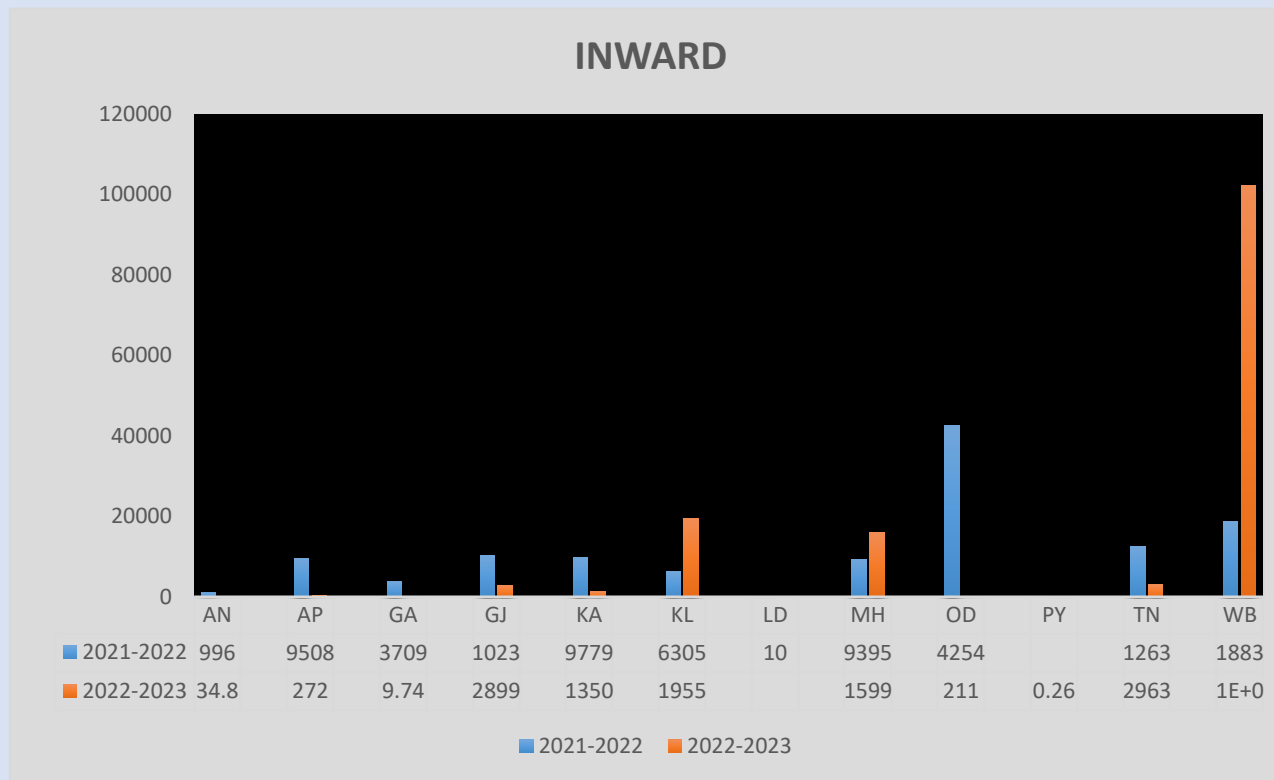
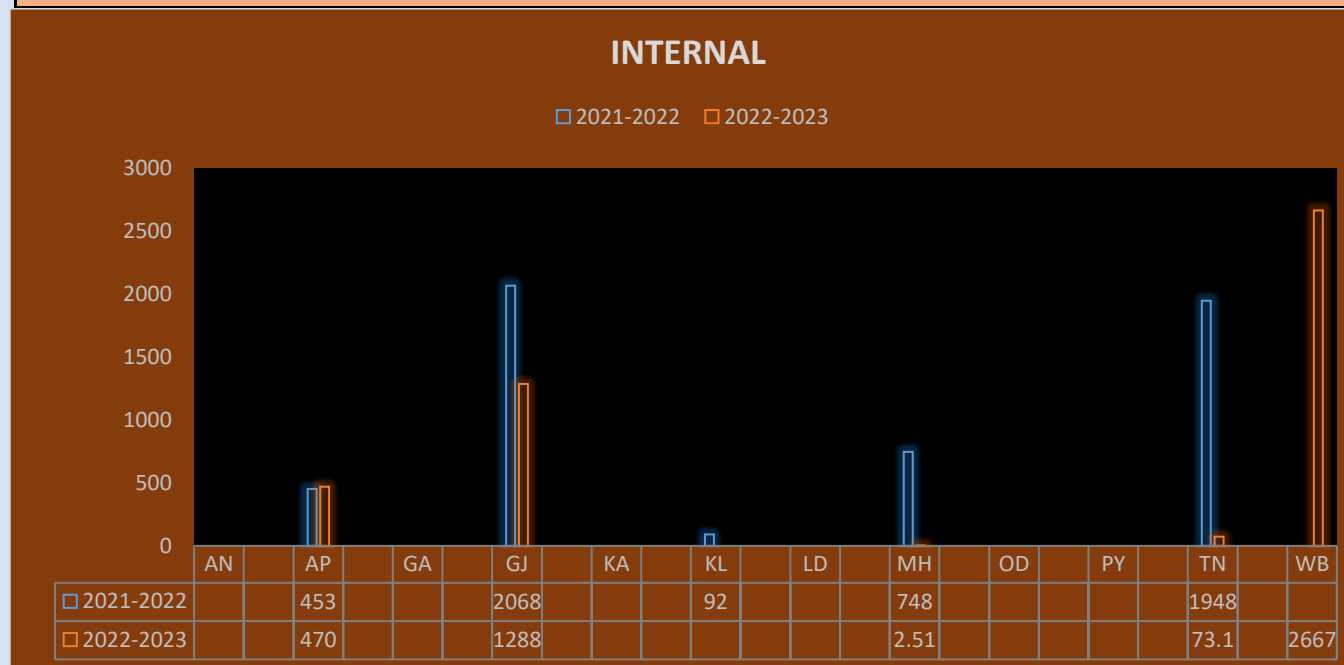


FIGURE 3.2A: Percentage Share of States/UTs* in total value related to INTERNAL movement of Goods from 2021-22 to 2022- 23

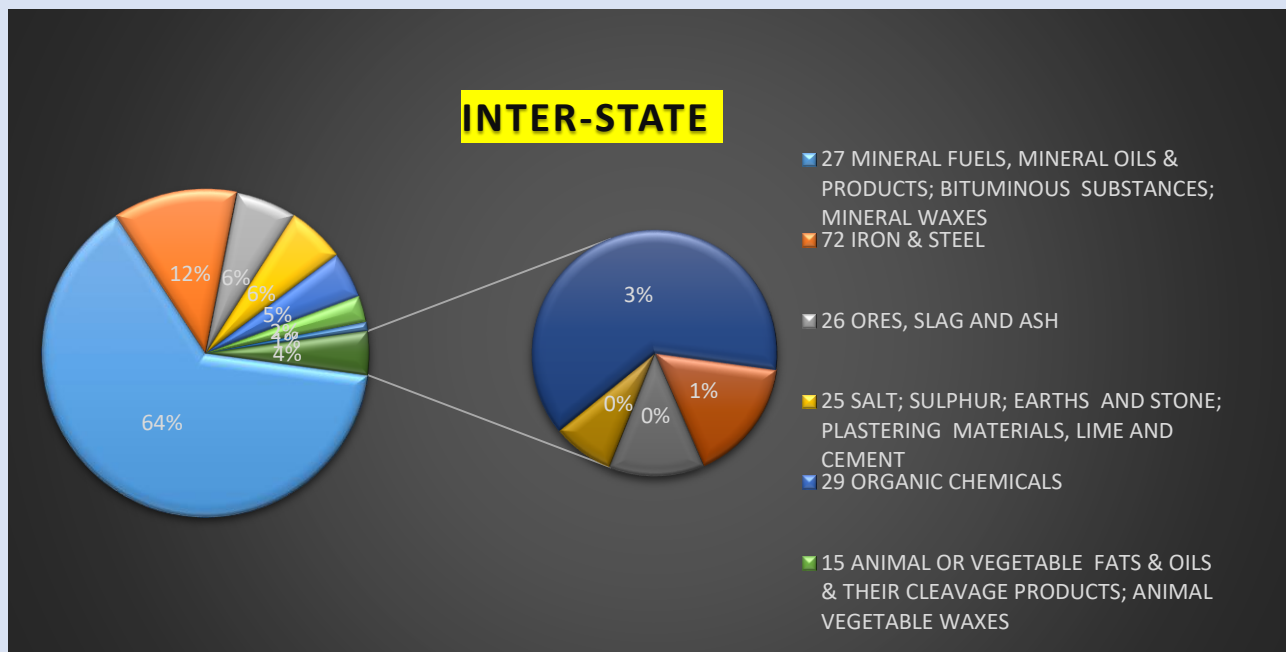

From the **STATEMENT 4.1V** and **FIGURE 4.1V** below, it is observed that during the period April 2022 to March 2023, HS 27 MINERAL FUELS, MINERAL OILS & PRODUCTS; BITUMINOUS SUBSTANCES; MINERAL WAXES had maximum share among **HS 02** digit Commodity having around 63.66% of total value of **INTER-STATE** movement. If included with HS 72 (IRON & STEEL) and HS 26 (ORES, SLAG AND ASH) it is about 81.87% of value of total **INTER-STATE** movement. SALT; SULPHUR; EARTHS AND STONE; PLASTERING MATERIALS, LIME AND CEMENT, ORGANIC CHEMICALS, ANIMAL OR VEGETABLE FATS & OILS & THEIR CLEAVAGE PRODUCTS; ANIMAL VEGETABLE WAXES, RESIDUES AND WASTE FROM THE FOOD INDUSTRIES; PREPARED ANIMAL FODDER, CERAMIC PRODUCTS, COTTON, AIRCRAFT, SPACECRAFT AND PARTS THEREOF and others also took place. During April 2021 to March 2022, HS 27 commodity had around 57.11% share total value of **INTER-STATE** movement

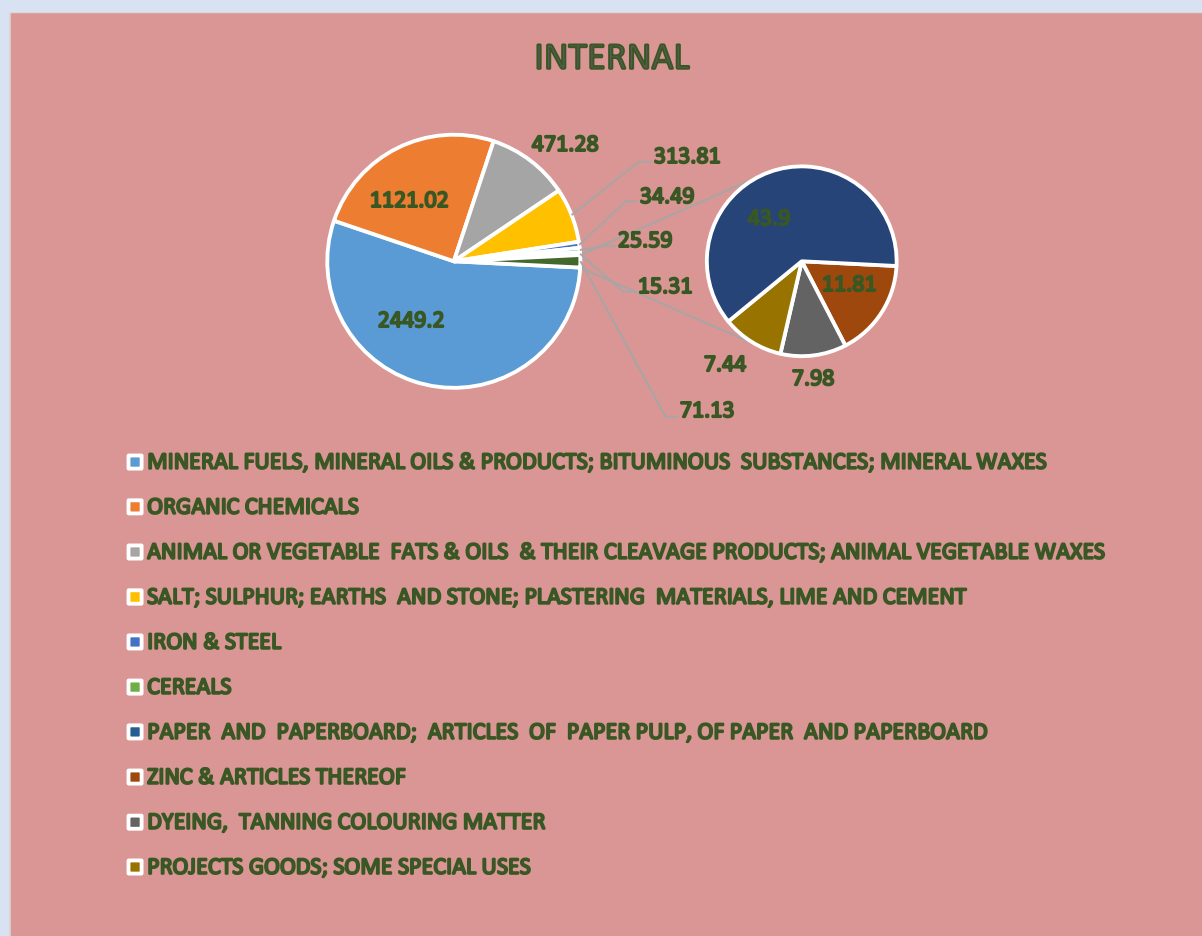

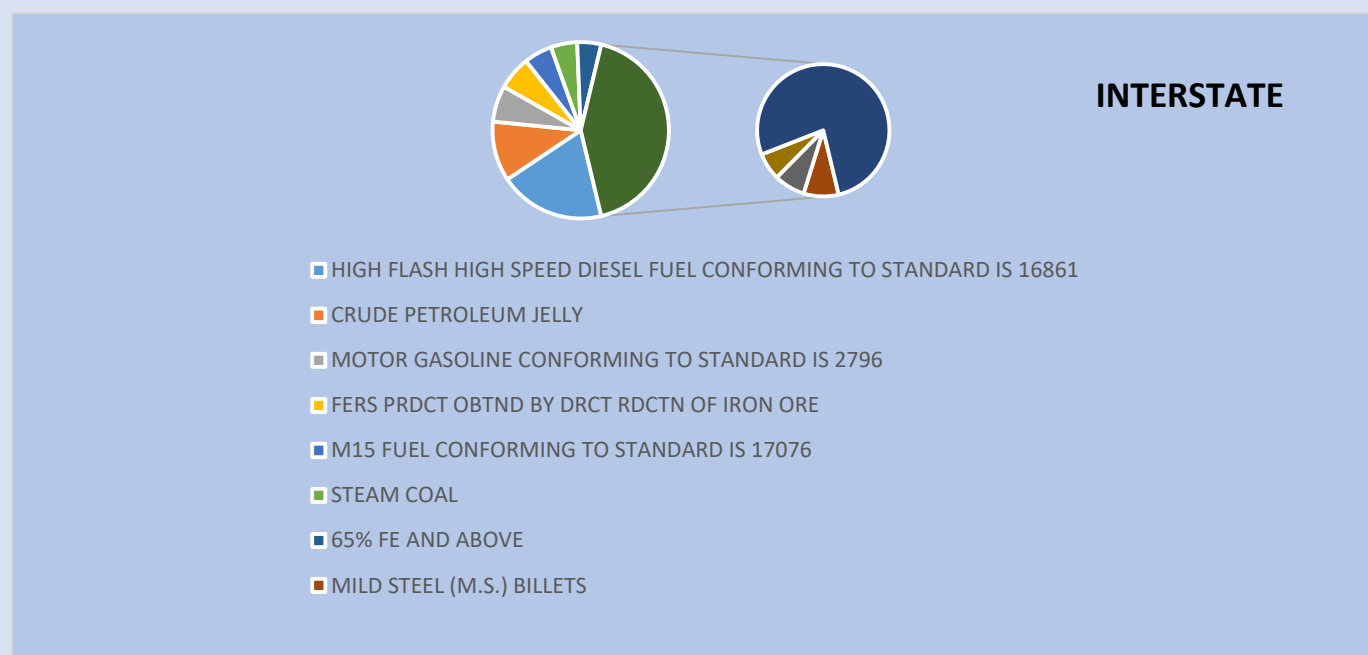
FIGURE 4.2V :: Pie chart showing share of Top Commodities (**HS2** digit) in **INTERNALSTATE** Movement of Inland Coasting Trade in VALUE in Rs. Crore

From the **STATEMENT 4.2V** and **FIGURE 4.2V** below, it is observed that during the period April 2022 to March 2023, HS 27 (MINERAL FUELS, MINERAL OILS AND PRODUCTS OF THEIR DISTILLATION; BITUMINOUS SUBSTANCES; MINERAL WAXES) comes out to be the leading **HS2** digit Commodity having around 54.4 % of value of **INTERNAL** movement, HS 29 (ORGANIC CHEMICALS) comes out to be the SECOND most **HS2** digit Commodity having around 24.9 % of value of **INTERNAL** movement and HS 15 (ANIMAL OR VEGETABLE FATS & OILS & THEIR CLEAVAGE PRODUCTS; ANIMAL VEGETABLE WAXES) comes out to be the THIRD highest **HS2** digit Commodity having around 10.47 % of value of **INTERNAL** movement. Thus the above three commodities and HS 25 (SALT; SULPHUR; EARTHS AND STONE; PLASTERING MATERIALS, LIME AND CEMENT) hold around 96.74% of value of **INTERNAL** movement of ALL Commodities

FIGURE 4.3V :: Pie chart showing share of Top Commodities (HS8 digit) in INTER-STATE

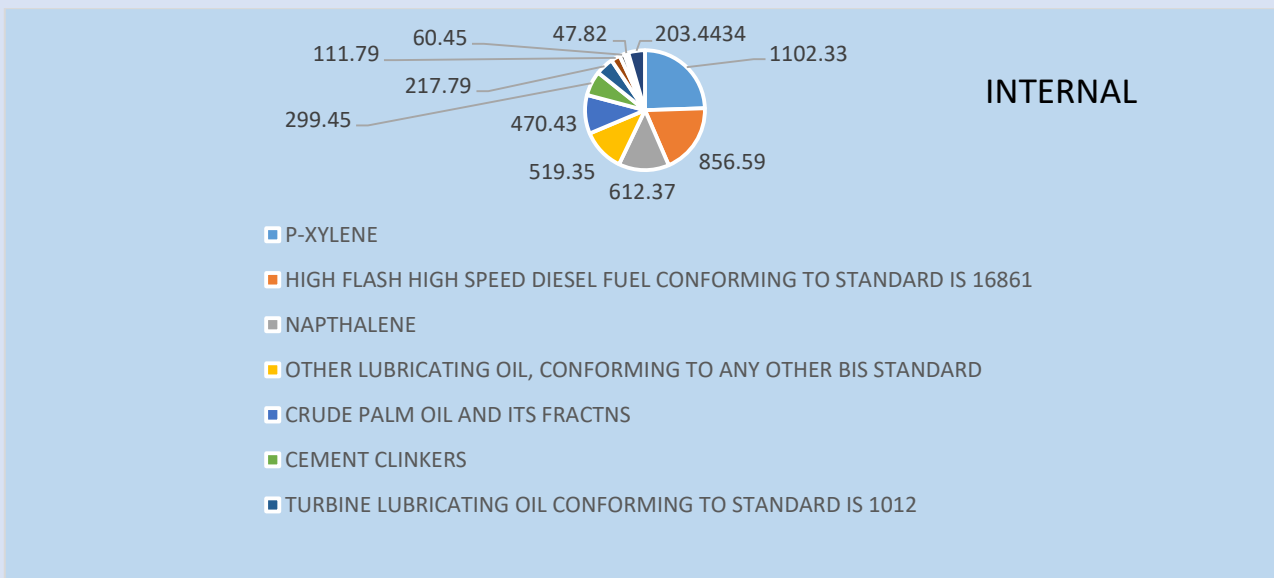


From the above **STATEMENT 4.3V** and **FIGURE 4.3V** it is observed that during the period April 2022 to March 2023, HS 27101949 (HIGH FLASH HIGH SPEED DIESEL FUEL CONFORMING TO STANDARD IS 16861) comes out to be the highest **ITCHS 8** digitCommodity with 19.37% of share in **INTER-STATE** movement followed by HS 27121010 (CRUDE PETROLEUM JELLY) having 10.95 % of value of **INTER-STATE** movement and HS 27101241 MOTOR GASOLINE CONFORMING TO STANDARD IS 2796 comes out to be the THIRD most **ITCHS 8** digit Commodity having around 6.62 % of value of **INTER-STATE** movement. Thus the above three commodities along with HS 72031000 (FERS PRDCT OBTND BY DRCT RDCTN OF IRON ORE) are found to have more than 42.75% of total value of **INTER-STATE** movement of ALL Commodities. During April 2021 to March 2022, HS 27101949 commodity had around 23.06% share total value of **INTER-STATE** movement.
